On recommendation of the State Level Committee in its meeting held on **03-06-2024 at 4.00 PM** in the office Chamber of Secretary to the Govt. of Assam, Department of School Education, 3rd Floor, Block-C, Janata Bhawan, Dispur and subsequently Govt. letter issued vide No. E-245335/1176, dated 11-06-2024 "No Objection Certificate" is hereby issued for affiliation under CBSE /ICSE curriculum to the **below mentioned Educational Institutions** on the following terms and conditions:

1. The Schools concerned will follow the terms and conditions as laid down in the "Assam Non- Govt. Educational Institutions (Regulation & Management) Act, 2006" as amended in 2018 and the "Assam Non-Govt. Educational Institutions (Regulation & Management) Rule, 2007" therein accordingly.
2. In case any anomaly is detected at any stage in respect of land documents, School building, reserved fund and other criteria, then the concerned school shall be disqualified from obtaining NOC affiliation under CBSE / ICSE and the NOC already issued to the School shall be revoked.
3. The Schools which are granted NOC for fresh affiliation to CBSE / ICSE courses shall establish linkage with Fee Regulatory Committee for fixation of fee structure.
4. Only the fresh registration of students will be allowed to register under CBSE / ICSE.
